PUEBLO DE SAN ILDEFONSO COUNCIL RESOLUTION NO. SI-R19-016

GOVERNMENTAL ORGANIZATIONAL ACT OF 2019

At a duly called meeting of the Council of San Ildefonso Pueblo on the 21st day of June, 2019, the following Resolution was adopted:

- WHEREAS, the Pueblo de San Ildefonso ("Pueblo") is a sovereign and self-governing Tribe, recognized as such by the United States of America; and,
- WHEREAS, a well-organized government with clear lines of authority and responsibilities will promote administrative efficiency and lower costs to deliver governmental services; and,
- **WHEREAS**, in 2012, the Council enacted a law approving a new organizational chart for the government to replace all previous organizational charts; and,
- **WHEREAS**, in 2016, the Council enacted a law approving a modified organizational chart for the government to replace all previous organizational charts; and,
- WHEREAS, the Pueblo is currently facing a number of significant matters involving water rights, land use, roads, and related development projects, placing increasing demands on the Pueblo's limited funds; and
- WHEREAS, beginning in FY 2019-2020, the Council intends to create new Departments within the government, including a new Department of Project Management and a new Tewa Language Department, requiring the reassignment and reorganization of duties and responsibilities among the Departments and with outside contractors; and
- **WHEREAS**, the Council has determined that creating and reorganizing various departments and duties will promote efficiency, reduce costs, and strengthen the Pueblo's long-term capacity to address critical matters; and,
- **WHEREAS**, the Council finds the need to enact and approve a revised organizational chart for the Pueblo to replace all previous organizational charts.

NOW THEREFORE BE IT RESOLVED, that the Council hereby enacts the attached law entitled "GOVERNMENTAL ORGANIZATIONAL ACT OF 2019."

PUEBLO DE SAN ILDEFONSO

GOVERNMENTAL ORGANIZATIONAL ACT OF 2019

Section 1.1 Short Title

This enactment shall be known as the "GOVERNMENTAL ORGANIZATIONAL ACT OF 2019 ("Act")."

Section 1.2 Purpose

The purpose of this Act is to adopt a revised organizational chart for the government of the Pueblo, and to repeal all prior organizational charts

Section 1.3 Findings

The Council hereby finds that:

- (a) A well-organized government with clear lines of authority and responsibilities will promote administrative efficiency and lower costs to deliver governmental services; and,
- (b) In 2012, soon after the adoption of the governing Agreement by the voters of the Pueblo, the Council enacted and approved an organization chart for the Pueblo to replace all previous organizational charts; and,
- (c) Subsequently, the Pueblo enacted a budget which attached a different organizational chart for the government; and,
- (d) In 2016, the Council enacted a law approving a single, modified organizational chart for the government to replace all previous organizational charts; and,
- (e) The Pueblo is currently facing a number of significant matters involving water rights, land use, roads, and related development projects, placing increasing demands on the Pueblo's limited funds; and,
- (f) Beginning in FY 2019-2020, the Council intends to create new Departments within the government, including a new Project Management Department and a new Tewa Language Department, requiring the reassignment and reorganization of duties and responsibilities among the Departments and with outside contractors; and,
- (g) The Council has determined that creating and reorganizing various departments and duties will promote efficiency, reduce costs, and strengthen the Pueblo's long-term capacity to address critical matters; and,
- (h) The Council finds the need to enact and approve a revised organizational chart for the Pueblo to replace all previous organizational charts.

Section 1.4 Governmental Organization

- (a) The Council hereby enacts and approves the attached organizational chart (Attachment A), which shall serve as the official organizational chart for the government of the Pueblo.
- (b) All prior organizational charts for the government of the Pueblo are hereby repealed.
- (c) The Governor shall not have the power to alter or modify the attached organizational chart (Attachment A).
