



**PUEBLO DE SAN ILDEFONSO
COUNCIL RESOLUTION NO. SI-R20-018**

**APPROVAL TO APPLY FOR THE FY 2020 TRIBAL TRANSIT PROGRAM (TTP)
COMPETITIVE GRANT PROGRAM TO BUILD BUS STOPS ALONG NORTH CENTRAL
REGIONAL TRANSIT DISTRICT (NCRTD) ROUTES IN THE
PUEBLO DE SAN ILDEFONSO**

At a duly called meeting of the Council of San Ildefonso Pueblo on the
27th day of August, 2020, the following Resolution was adopted:


- WHEREAS**, the Pueblo de San Ildefonso (“Pueblo”) is a sovereign and self-governing Tribe, recognized as such by the United States of America; and,
- WHEREAS**, on May 26, 2020, the Federal Transit Administration (FTA) published a Notice of Funding Opportunity (NOFO) for the FY 2020 Tribal Transit Program (TTP) Competitive Grant Program; and,
- WHEREAS**, proposals for FY 2020 TTP Competitive Grant Program funding are due by August 24th, 2020; and,
- WHEREAS**, the North Central Regional Transit District (NCRTD) has indicated that the construction of bus stops along NCRTD routes in the Pueblo de San Ildefonso is expected to improve accessibility to public transit service, passenger experience and ridership numbers; and,
- WHEREAS**, the NCRTD has requested to collaborate with the Pueblo de San Ildefonso to apply for the FY 2020 TTP Competitive Grant Program on behalf of the Pueblo de San Ildefonso; and,
- WHEREAS**, if selected to receive FY 2020 TTP Competitive Grant Program funding, the Pueblo de San Ildefonso will allocate funding to NCRTD specifically for building ADA-compliant bus stops in the Pueblo de San Ildefonso; and,
- WHEREAS**, the grant requires a 10% local match which will be provided by the NCRTD, if the FY 2020 TTP Competitive Grant Program funding is awarded.
- NOW THEREFORE BE IT RESOLVED**, that the Pueblo de San Ildefonso Council hereby grants authorization to apply for the FY 2020 Tribal Transit Program (TTP) Competitive Grant Program for funding to build bus stops along NCRTD routes in the Pueblo de San Ildefonso.

NOW THEREFORE BE IT FINALLY RESOLVED, that

1. In order to receive FY 2020 Tribal Transit Program (TTP) Competitive Grant Program funds, the NCRTD will provide the required 10% local match; and,
2. The funding, if awarded, will be dedicated exclusively to designing and building bus stops along NCRTD routes in the Pueblo de San Ildefonso.



Section 1.1 Short Title

This enactment shall be known as the "APPROVAL TO APPLY FOR THE FY 2020 TRIBAL TRANSIT PROGRAM (TTP) COMPETITIVE GRANT PROGRAM TO BUILD BUS STOPS ALONG THE NORTH CENTRAL REGIONAL TRANSIT (NCRTD) ROUTES IN THE PUEBLO DE SAN ILDEFONSO."

Section 1.2 Purpose

The purpose of resolution is to grant authorization to the North Central Regional Transit District (NCRTD) to apply for the FY 2020 Tribal Transit Program (TTP) competitive grant program to build bus stops along the NCRTD routes in the Pueblo de San Ildefonso.

Section 1.3 Findings

- (a) On May 26, 2020, the Federal Transit Administration (FTA) published a Notice of Funding Opportunity (NOFO) for the FY 2020 Tribal Transit Program (TTP) Competitive Grant Program; and
- (b) Proposals for FY 2020 TTP Competitive Grant Program funding are due by August 24th, 2020; and
- (c) The North Central Regional Transit District (NCRTD) has indicated that the construction of bus stops along NCRTD routes in the Pueblo de San Ildefonso is expected to improve accessibility to public transit service, passenger experience and ridership numbers; and
- (d) The NCRTD has requested to collaborate with the Pueblo de San Ildefonso to apply for the FY 2020 TTP Competitive Grant Program on behalf of the Pueblo de San Ildefonso; and
- (e) If selected to receive FY 2020 TTP Competitive Grant Program funding, the Pueblo de San Ildefonso will allocate funding to NCRTD specifically for building ADA-compliant bus stops in the Pueblo de San Ildefonso; and

Section 1.4 Authorizations

- (a) The Pueblo de San Ildefonso hereby grants authorization to apply for the FY 2020 Tribal Transit Program (TTP) Competitive Grant Program for funding to build bus stops along the NCRTD routes in the Pueblo de San Ildefonso.
- (b) In Order to receive the FY 2020 Tribal Transit Program (TTP) Competitive Grant Program funds, the NCRTD will provide the required 10% local match; and
- (c) The funding, if awarded, will be dedicated exclusively to designing and building bus stops along the NCRTD routes in the Pueblo de San Ildefonso.
